

Dear VA SNHCS Leadership,

I am FED. UP. with male homosexual (#MHSX) Veterans HARASSING ME IN YOUR FACILITIES. In the past three years, in EVERY satellite clinic, and ESPECIALLY the NLV Pecos #MainHospital. The number of #HarassmentEvents is directly proportional to the number of #MHSX Veterans present. On one Pecos three-hour visit, I counted TWENTY- FIVE separate #MHSX harassment events. I confronted two of these #MHSX sexual predators quietly and verbally in the pharmacy waiting room yesterday. The next time(s) I WON'T do it quietly. I have a VERY LOUD voice and I WILL use it. Moreover, I will take the VASNHC'S WILLFUL complicity in its #SexualHarassment problem PUBLIC, and I KNOW that the VA does NOT want that and will avoid it at ALL COSTS. Akin to the CCP, the VA is CORRUPT and relies on its public image to perpetrate and perpetuate its corruption. #ThisIsEASY.

Moreover, I KNOW this VA tried to set me up three times over the past year, and twice since I filed my #SexualHarassment complaint against Provider Neilson. Once in a Radiology exam room, and again while I was waiting FOR Radiology in the hallway.
